Working Out of the Area – What it Means for Your Pension **Benefits**

It is not uncommon for members to work in jurisdictions outside of their home local's geographic area. Whether you are taking a maintenance call in Sheboygan or working a month-long stint in Dubugue, lowa, where you work may affect the pension fund to which your employer should be contributing.

Before accepting any assignment for out-of-jurisdiction work, you should first check with the your local union to see whether there are any contribution obligations referenced within the relevant collective bargaining agreement (CBA) for out-of-jurisdiction work. In some instances, you may not need to do anything, and your benefits will remain with the BTUPTF. In other instances, you may need to fill out retention or transfer authorization paperwork to ensure your benefits remain with the BTUPTF.

In most instances, pension contribution obligations are tied to the land where the work is performed, meaning geographic location will determine which fund your pension contributions are sent, not the jurisdiction of your home local. If you are working outside of the geographic jurisdiction of the BTUPTF, it may be required that your pension contributions be paid to the designated pension fund for the area you are working.

Largely, it is the obligation of your employer to follow their CBA and contribute to the appropriate funds, but members should always be conscious of where their contributions are going. If a member works outside the BTUPTF's jurisdiction and wishes for their benefits to remain with the BTUPTF, they must contact the Fund Office to complete a Pension Transfer Request Form prior to beginning work outside of the jurisdiction.

Likewise, if a member from out of the jurisdiction is working within the BTUPTF's area but wishes to have their pension benefits stay with their home fund, the member should contact their home pension fund to complete the necessary paperwork to have their benefits transferred appropriately. Do not wait to complete this process!

We recommend you contact the Fund Office for your home jurisdiction prior to working out of area to make sure proper procedures are followed and member benefits end up where intended. Members should discuss this with their employer to make sure they are paying benefits to the appropriate funds. Employers should also check the language of their CBA and discuss questions with their Union partners to ensure benefits are paid to the proper funds and at the proper rates.

Contribution obligations vary from contract to contract. Before working out of jurisdiction, contact your local business representative to see if any of these procedures apply to you.
